I have been discussing our grant application with Donna Conner and she said it is under active review. Donna estimates that, if we should get an award, it could come as early as July1, but that is not a certainty.

For planning purposes, you should note the following critical dates.

Assuming a July 1, 2012 award notice then the following thresholds apply:

August 1, 2012, notice to feds that we accept the grant  
November 1,2012, grant funded employees on SKF&R payroll  
October 30, 2014, federal funding ends

If these dates hold, and we wish to go forward with accepting the grant, then there will be a need to hire during 2012 and preparation will need to begin soon.
